Dear Neighbors,

I write this in anticipation of Halloween, one of my favorite holidays. One of the first times I realized what a great community we have in Miller Heights was my first Halloween in the neighborhood. In my old neighborhood in Herndon, each year there were less and less houses open for trick or treaters, but Miller Heights has the spirit of Halloween! The distance traveled per treat (or trick) is sometimes daunting, but most houses are open for business with elaborate decorations and the occasional scare.

#### A Message from Supervisor Dalia Palchik

Dear Miller Heights neighbors,

I hope you are doing well following the start of the school year and this past weekend's Halloween festivities! The mornings are starting to get crisp, and I've enjoyed the variety of colors in the foliage around our district.

My team and I are always working on improving the ways in which constituents can engage with our office and County resources. Here are some items that are top-of-mind for me:

#### **Annual Providence District Food Drive**

My office, along with several community partners, is hosting our 6th Annual Food Drive through November 15th for Food for Others, and the food pantries at Oakton High School, Woodson High School, and Falls Church High School.

#### Federal Government Shutdown

#### Federal Workforce Resource Hub

The effects of the government shutdown are being especially felt by our neighbors and community members. Fairfax County has prepared a 'Federal Workforce Resource Hub' which outlines resources available to furloughed federal employees. It can be accessed <a href="here">here</a>.

#### **SNAP Benefits**

The State has created an emergency food assistance program called Virginia Emergency Nutrition Assistance (VENA). VENA will provide emergency food assistance to eligible SNAP households while the federal shutdown continues. VENA benefits will be issued weekly, instead of monthly. Learn more here.

#### **Oakton Traffic Study**

The Fairfax County Department of Transportation (FCDOT) will hold a Community Workshop for the Oakton Congestion Mitigation and Safety Study on Thursday, Nov. 13, 6:30 p.m., at Oakton High School, 2900 Sutton Road, Vienna.

The workshop will include a brief presentation from staff to introduce the project and a mapping exercise, which will divide attendees into small groups and allow the public to share their recommendations to improve transportation in Oakton. **Register here**.

#### Help with Invasive Plant Removal

All are invited to participate in a "Week of Action", November 8-16, when people across Fairfax County will come together to rescue trees from invasive vines. This is

the official launch of Fairfax Tree Rescuers Partnership PRISM (Partnership for Regional Invasive Species Management), a community-wide initiative to save our trees and natural areas from the invasive plants that are smothering and strangling them. Find dates, locations, and register here.

#### Department of Public Works & Environment Open House

DPWES is hosting their Open House at the Noman M. Cole, Jr. Water Recycling Facility. My team and I just toured the facility earlier this month and it is definitely a must see. Their theme this year is A Sweet Journey to Clean Water. Visitors can participate in a variety of activities, and there will be a Touch-a-Truck event for kids, as well as bus, tunnel and walking tours of the facility. Festive drinks and snacks will be provided. But there's also an educational component so visitors can learn what happens to their water when it goes down the drain. 





FCDOT sent a press release for the first Oakton Congestion and Safety study meeting, which will be held at the Oakton High School cafeteria on Thursday, November 13<sup>th</sup> at 6:30 PM

This first meeting will include a brief presentation covering the project background, scope, and timeline. followed by a community workshop and discussion. The workshop will group participants into tables, each with a large map of the study area and drawing materials. A facilitator will be present at each table to help participants discuss their ideas and priorities for Oakton., cost, etc.

#### Workshop Purpose

The Fairfax County Department of Transportation (FCDOT) will be conducting a congestion mitigation and safety study for the Oakton area. The study will evaluate different roadway improvements and come up with short and long-term improvements. Recommended improvements will also consider the impacts to the bicycle, pedestrian, and bus networks in the study area, including impacts to safety for all roadway users.

This workshop will include a brief project presentation, and will be followed by a group activity where participants will present ideas and discuss priorities for short and long-term improvements.

### Sara Holtz Received the Sally Ormsby Environmental Stewardship Award

Huge congratulations to Sara Holtz for receiving the 2025 Sally Ormsby Environmental Stewardship Award from Fairfax County Park Authority!

Since 2017, Holtz has led 230+ Invasive Management Area (IMA) volunteer sessions in Fairfax County Parks, focusing on invasive removal, native planting, youth mentorship and community education to protect Fairfax County's natural resources.

## **Fall Plantings in Fencing to Prevent Deer Browse**

Fairfax County Park Authority Invasive Management Area (FCPA IMA) site leaders Tucker Newberry, Nick Newberry, Karin Lehnigk & Sara Holtz lead habitat restoration efforts on parkland in our neighborhood by removing invasive plants & planting native plants. In September they planted Christmas ferns, sensitive ferns, swamp white oak, sycamore, and winterberry inside a deer exclosure (fencing) to protect the young plants from deer browse. In October they planted 65 native plants including asters, blue wild indigo, yellow wild indigo, columbine, and poverty oats in a larger deer exclosure. You can see the deer exclosures near the big brown park sign and near the cement sidewalk (where the Miller Rd extension meets the Cross County Trail)

## "Compromise in the Garden: Piles, Projects, and Prickly Pears" By Farmer Brown (Gordon)

I hear the looks of disapproval as I write this, and can see the tsk, tsk, tsks as well. Yes, yes, I cleaned up my yard last week. You may be thinking, hypocrite, he tells us NOT to tidy the yard until late spring / early summer. And, yes, yes, I do and I stand by that. However, I'm trying a new approach this year... while I have left the leaves, I have trimmed some things back, I have not thrown my yard debris away, I've consolidated the like for like (dead seed heads and dry stalks) into bunches and placed those in their own area around my compost boxes. The Jerusalem artichokes, and milkweed stalks, both excellent options for boring insects, will continue to be a nesting option with the way they are stacked. All the echinacea's have been placed in piles between my berry fences for the hordes of gold finches to enjoy, and any they miss, I hope, will self-seed. The asters, now that they are done, have been transplanted to a spot lower in my yard. I still have lingering figs that have not yet ripened and in years past, I have collected these and made a delicious bright green fig jam, there just are not enough left over to do much with. Next spring I'll trim some of the smaller branches and see if I can't get them to root.

Repairing our deck has left me with some timber that I have great plans for. The first is to construct a few fence panels to protect my strawberries which are currently hiding below Dollar Tree wastepaper baskets, fearing for their very lives as marauding deer wonder through my garden, undeterred by tight spaces, lights, and other sundry "deer prevention hacks". My father-in-law will be out over thanksgiving, so that could give him something to do, even though he doesn't know it yet. And the second, possibly his second task, is to construct a bed for some type of mushroom – still to be determined, under my deck. I like mushrooms but my family hasn't come round to them just yet. More to come on this effort to correct un-inspired palates.

What has been exciting this year is that my eastern prickly pears bore me some fruit. I picked them, but they're still a bit green, because I needed to re-pot them. I was tired of being impaled every time I wondered about my veggie patch by 4-inch spines and wasn't a fan of the tiny hairs that poke into you when you touched a leaf pad. However, I do like this and hope the new location and tight fencing around them will give them room to impress me next year.





Now, one thing that has thoroughly confused me this year is that I have fully grown pepper plants and cape gooseberry plants dating back to June. Both are only now flowering and fruiting, just in time for the frost action we are getting. I have one green pepper that is about the size of a gobstopper and two the size of peas. They had the prime spot in the garden, were looked after fastidiously and now reward all my love and attention with lunchbox sized yields and one pretty flower. This is why I only grow basil, cherry tomatoes and beans. Why? Because, sun. And to be fair, I grow other things like beans (which were prolific to say the least this year), salad things and herbs.

And while I sometimes think my family is allergic to the great outdoors or maybe it is just when there's gardening work to do, what has brought everyone together is the great daily lanternfly killing. Our grapes were the target of the first infestation this year, but now since those were trimmed back (remember my deck project) the lantern flies have found our Japanese Snowbell to their liking. This is convenient because I can reduce their numbers from my desk using a BB Gun. And then, when everyone gets home, we knock them off the tree and stomp on them. So, if you do happen to drive past, it's not a barn dance lesson in full swing, it's just us taking care of the invasive bug population.

## Unlawful and Dangerous Practice of Prescribing Wildlife as Emotional Support Animals

The Virginia Department of Health Professions (DHP), in coordination with the Virginia Department of Wildlife Resources (DWR), is issuing this important advisory regarding the **prescription or recommendation of wildlife as emotional support animals (ESAs).** 

Please be advised that:

- It is illegal in Virginia to possess wildlife as pets, regardless of whether the animal is prescribed or recommended as an emotional support animal.
- Prescribing or endorsing the use of wild animals as ESAs is both unlawful and dangerous.
- Wildlife possession without proper permits is a violation of Virginia law and may result in **confiscation of the animal**, legal penalties, and potential disciplinary action.
- Key Concerns:
- Public Health and Safety: Wild animals can carry diseases that can be transmitted from animals to humans, and pose unpredictable behavioral risks, endangering the patient and the public.
- Animal Welfare: Removing wildlife from their natural habitat is detrimental to their well-being and survival.
- Patient Harm: Confiscation of an illegally possessed animal can cause additional emotional trauma to the patient, undermining therapeutic goals.

We urge all licensed practitioners to **refrain from recommending or prescribing wild animals** as emotional support animals under any circumstances. If you are unsure whether a species is considered wildlife under Virginia law, please consult the Department of Wildlife Resources. ### **Loose Ends**

During the pandemic I joined a group called "Loose Ends," a group of volunteers who finish fiber related work, such as knitting, crochet or quilting that was started but left unfinished by a loved one due to illness or death. Even though I have my own healthy pile of unfinished work I was drawn to the idea of helping others through their grief by using my hands and skills. I listed my set of skills on the application form and waited for the projects to roll in to me. I joined a Face Book group for Loose Ends Finishers and was heartened by the stories of project owners and project finishers working together to complete a loved ones work and I waited patiently to be called. I waited for several years. As it turns out many other people felt the call to help in this way, and the ratio of finishers to projects is roughly 12 to 1. I have finally been asked to help finish a quilt for the daughter of a woman who died three years ago. We are working out a time when we can meet and discuss the best way forward with this project.

I like the philosophy of this group, as exemplified by these statements from their web page:

"Loose Ends aims to ease grief, create community, and inspire generosity by matching volunteer handwork finishers with textile projects people have left undone due to death or disability."

"We are matchmakers."

In knitting patterns, this is noted as K2Tog (knitting two together).

When Loose Ends receives a project submission, we look through our database of finishers to find a good match. With an eye toward geography, skill level, and druthers, we will identify a good fit based on the information volunteer finishers submitted in their profiles. The next step is running this by the finishers themselves to find out if they're feeling it too.

Once a finisher says yes to a project, we make the connection by introducing the finisher and project holder in an email. Then... we step away and let the project evolve within this new connection. We are always here to troubleshoot, advise or reassign if needed."

If you are interested in becoming a finisher, or, if you have a project you would like finished, please check out the website looseends.org. The website also has several videos and press releases, including the time the project was mentioned on the TV show Jeopardy. I am looking forward to my own work with this wonderful project.


## **Successful Miller Heights BASH**


